Resolution of Support for E-911 Wireless Fee

Whereas, the Grady County Emergency Management Agency processes incoming 911 calls on behalf of the Town of Bradley.

Whereas, the number of 911 calls received from wireless phones is increasing each month.

Whereas, many times callers on wireless phones cannot accurately tell the 911 operator where they are, thereby delaying the response of emergency crews.

Whereas, technology now exists that allows for the wireless callers location to be displayed in the 911 center, speeding the arrival of emergency responders and potentially saving lives.


Whereas, Grady County has called for a special election on December 13, 2005 to approve a fifty cent (\$0.50) per month fee on all wireless phones to help cover the cost of implementing and maintaining this new technology.
