

R E S O L U T I O N

WHEREAS, the Board of Trustees of the Town of Bradley, Oklahoma, duly enacted Ordinance No. 72-1 granting to Public Service Company of Oklahoma a franchise for the distribution and sale of electricity within said Town, and ordering such ordinance submitted for ratification at a special election, as provided by law; and

WHEREAS, such special election was lawfully held in said Town on the 21st day of March, 1972, and said ordinance, and the franchise thereby granted, was duly approved and ratified by the electors of said Town, in that 43 votes were cast in favor of same, and only 0 votes against same, as shown by canvass of the returns of said election made by election officials and by the County Election Board of Grady County, Oklahoma; and

WHEREAS, in pursuance of said ordinance and of said election ratifying same, Public Service Company of Oklahoma, on the 4 day of April, 1972, duly filed with the Town Clerk its written acceptance of said franchise.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF BRADLEY, OKLAHOMA:

SECTION 1. That said Ordinance No. 72-1, and the franchise therein granted, having been duly ratified and approved by the electors of said Town, and having been duly accepted by said Company as provided by law, is hereby declared to be in full force and effect as of the date on which such acceptance was so filed.

Passed by the Board of Trustees of the Town of Bradley, Oklahoma, and approved by the President of said Board on this the 4 day of April, 1972.

ACCEPTANCE OF FRANCHISE

WHEREAS, on the 15th day of February, 1972,
the Board of Trustees of the Town of Bradley,
Grady County, Oklahoma, duly enacted and passed
Ordinance No. 72-1, which was approved by the President of
the Board of Trustees of said Town on said day, which said ordi-
nance was entitled:

AN ORDINANCE GRANTING TO PUBLIC SERVICE
COMPANY OF OKLAHOMA, AN OKLAHOMA CORPORA-
TION, AND ITS SUCCESSORS AND ASSIGNS, A
FRANCHISE TO USE THE STREETS, ALLEYS AND
OTHER PUBLIC PLACES IN THE TOWN OF
BRADLEY, GRADY
COUNTY, OKLAHOMA, FOR THE PERIOD OF TWENTY-
FIVE (25) YEARS FROM THE ACCEPTANCE HEREOF
FOR THE PURPOSE OF BUILDING, EQUIPPING,
MAINTAINING, EXTENDING, OWNING AND OPERATING
A SYSTEM AND PLANT FOR THE MANUFACTURE, TRANS-
MISSION, DISTRIBUTION AND SALE OF ELECTRICITY
IN AND TO SAID TOWN AND THE PUBLIC GENERALLY,
AND TO TRANSMIT ELECTRIC ENERGY THROUGH THE
TOWN TO OR FROM SYSTEMS IN OTHER LOCALITIES;
AND FIXING THE COMPENSATION TO BE PAID
THEREFOR AND THE TIME OF PAYMENT AND THE
MANNER OF DETERMINING THE AMOUNT TO BE PAID
BY THE COMPANY;
AND CONTRACTING FOR FURNISHING ELECTRI-
CITY FOR MUNICIPAL PUMPING AND STREET LIGHT-
ING;
AND DECLARING AN EMERGENCY;
AND WHEREBY THE SAID QUESTION IS SUBMITTED
TO A VOTE OF THE QUALIFIED ELECTORS, RESIDENTS
AND CITIZENS OF SAID TOWN AT A SPECIAL ELEC-
TION CALLED AT WHICH SUCH QUESTION SHALL BE
SUBMITTED.

and

WHEREAS, by said ordinance it is provided that the said
ordinance and all of the terms, provisions, rights and obligations
thereof, and all franchises and contracts therein contained, if
approved by the electors of the Town of Bradley,
Oklahoma, shall become effective, providing Public Service Company
of Oklahoma shall, within thirty (30) days after the result of such
special election is declared, file with the Town Clerk of said Town
its acceptance, in writing, duly executed according to law, accepting
all of the terms, provisions, conditions and obligations thereof; and

WHEREAS, there having been a special election duly held
on the 21st day of March, 1972, for the considera-
tion of said ordinance, franchise and contracts, and as a result

thereof, on the 22nd day of March, 19 72, the County Election Board of Grady County, Oklahoma, in the form and manner provided, did declare that the said ordinance was duly and regularly approved, passed and carried at said election by a vote of 43 cast in favor of same, there having been 0 votes cast against same;

NOW, THEREFORE, Public Service Company of Oklahoma, an Oklahoma corporation, being the grantee mentioned in said Ordinance No. 72-1, does hereby, in writing, in all things, accept the said ordinance, franchise and contracts, and all of the terms and provisions thereof.

IN TESTIMONY WHEREOF, witness the corporate name of said Public Service Company of Oklahoma hereunto subscribed by its President and witness its corporate seal hereunto affixed and attested by its Secretary, each of said officers being authorized so to do.


