ORDINANCE NO. 2-67

AN ORDINANCE RECOGNIZING THE STATUTORY AUTHORITY OF RURAL WATER DISTRICT NO. 3, GRADY COUNTY, OKLAHOMA, TO USE THE STREETS, ALLEYS, PUBLIC WAYS, RIGHTS-OF-WAY, EASEMENTS OR OTHER SIMILAR PROPERTY OWNED AND HELD BY THE TOWN OF BRADLEY, OKLAHOMA, IN CONNECTION WITH THE ACQUISITION, CONSTRUCTION, IMPROVEMENTS, OPERATION, OR MAINTENANCE OF ITS TRANSPORTATION, AND DISTRIBUTION LINES, SYSTEMS, EQUIPMENT, FACILITIES OR APARATUS: CONCURRING IN THE LOCATION OF SUCH LINES AND FACILITIES THEREOF AS SHOWN IN THE MAP AND PLAT OF SAID SYSTEM ON FILE IN THE OFFICE OF THE TOWN CLERK: AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE BOARD OF TRUSTEES of the Town of Bradley, Oklahoma.

Section 1. That the Board of Trustees of the Town of Bradley, Oklahoma, hereby recognizes the statutory authority of Rural Water District No. 3, Grady County, Oklahoma, under the provisions of the Oklahoma Rural Water Districts Act, as amended (82 Okl. Stat. Ann. Sec. 1301-1321), to use the streets, alleys, rights-of-way, easements or other similar property rights and the lands owned or held by the Town of Bradley, Oklahoma, in connection with the acquisition, construction, improvement, operation or maintenance of the transportation and distribution lines, system, equipment, facilities or apparatus of said Rural Water District, subject to the concurrence of the Board of Trustees as to the location of such lines and facilities.

Section 2. That the Board of Trustees of the Town of Bradley, Oklahoma, hereby concurs and approves of the location of the water lines and water distribution system and facilities of said Rural Water District No. 3, Grady County, Oklahoma, in the streets, alleys, public ways and on lands owned or held by the Town of Bradley, Oklahoma, as shown and specified by the plat and map of said water distribution system, prepared by GROUND WATER ASSOCIATES, dated MARCH, 1964, now on file in the office of the Town Clerk of the Town of Bradley, Oklahoma.

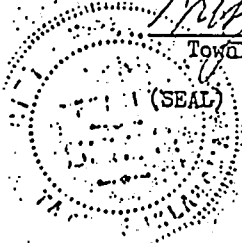
Section 3. By reason of the fact that the Town of Bradley, Oklahoma, has an inadequate supply of water for domestic use, and for the purpose of protecting and promoting the public health, safety and welfare of said Town and its inhabitants, an emergency is hereby declared to exist by reason whereof this ordinance shall become effective immediately upon its passage, approval and publication as provided by law.

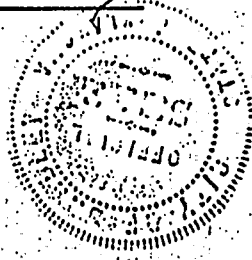

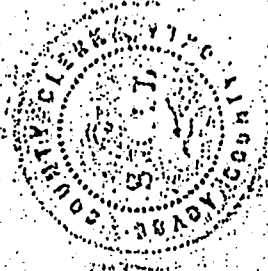

AN ORDINANCE CONSENTING TO THE INCLUSION OF THE AREA WITHIN THE CORPORATE LIMITS OF THE TOWN OF BRADLEY, WITHIN THE TERRITORY OF PROPOSED RURAL WATER DISTRICT NO. 3, GRADY COUNTY, OKLAHOMA; AUTHORIZING AND DIRECTING THE PRESIDENT OF THE BOARD OF TRUSTEES OF SAID TOWN TO PETITION THE BOARD OF COUNTY COMMISSIONERS OF GRADY COUNTY, OKLAHOMA, ON BEHALF OF SAID TOWN TO CREATE SAID RURAL WATER DISTRICT NO. 3, GRADY COUNTY, OKLAHOMA; AND DECLARING AN EMERGENCY.

WHEREAS, the Town of Bradley is without adequate water supply and distribution system and a sewage disposal system to serve the citizens and residents of said Town; and

WHEREAS, an adequate water supply and distribution system and a sewage disposal system to serve the citizens and residents of said Town can best be obtained by cooperating with rural residents in the incorporation of a Rural Water District pursuant to the provisions of the Oklahoma Rural Water Districts Act, as amended (82 Okl. Stat. Ann. SS 1301-1321), and

WHEREAS, FRED DEONIS, CARL STEPHENSON and \_\_\_\_\_ propose to sign a Petition for the incorporation of Rural Water District No. 3, Grady County, Oklahoma, for presentation to the Board of County Commissioners of Grady County, Oklahoma, such District to embrace the lands described in said Petition, including the area within the corporate limits of the Town of Bradley, as well as areas outside the corporate limits of said Town, which Petition is now on file with the Town Clerk; and

WHEREAS, the Board of Trustees has examined the Petition and determined that the public health, convenience, safety, and welfare of the citizens of said Town will be protected and promoted by including said Town in the proposed Rural Water District; and

WHEREAS, the Board of Trustees desires to consent, as required by law, that the Town of Bradley, having a population of 250 persons, according to the last decennial census, be included within the boundaries of the proposed Rural Water District, and to authorize and direct the President of the Board of Trustees to sign and execute the Petition for and on behalf of said Town;

NOW THEREFORE:

BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF BRADLEY, STATE OF OKLAHOMA:

Section 1. That the Town of Bradley hereby consents to the inclusion of all of the area within its corporate limits with the territory of proposed Rural Water District No. 3, Grady County, Oklahoma, said territory being more particularly described as follows:


ALL of the East Half of Section 27 and ALL of the West Half of Section 26, Township 5 North, Range 5 West, Grady County, Oklahoma.

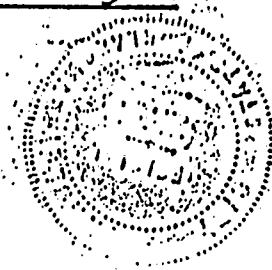
Section 2. That the town of Bradley, Oklahoma, shall be one of the Petitioners for the creation of Rural Water District No. 3, Grady County, Oklahoma, and that the President of the Board of Trustees is hereby authorized and directed to sign and execute the Petition for and on behalf of the Town, file the Petition with the Board of County Commissioners of Grady County, Oklahoma, and take such further action as may be necessary to incorporate and organize said Rural Water District.

Section 3. EMERGENCY: Whereas, an immediately necessity exists for the passage of this ordinance, therefore, for the preservation of public peace, health, and safety, an emergency is hereby declared to exist and by reason of same, this ordinance shall be in full force and effect from and after its passage and approval.
