# Bradley Water System Ready

Residents of Bradley can now begin using water from the new-constructed, 85-foot tower, it

DECISION OF THE COURT ON APPEAL

The Oklahoma Water Resources Board entered its Final Order No. 33 on August 12, 1969, which determined vested surface water rights in the Washita River Stream System which granted to Foss Reservoir Master Conservancy District 30,000 acre-feet as a vested right with priority date of February 9, 1951, and a permit of 36,900 acre feet with appropriative priority of July 25, 1968.

The Foss Reservoir Master Conservancy District filed its appeal of Final Order No. 33 in this Court on October 2, 1969, asking a modification of Final Order No. 33 which would establish the priority for the vested rights of the United States of America and the District in the amount of 66,900 acre feet as of February 9, 1951.

Voluminous records and documents have been agreed upon and made a part of the record in this appeal. On November 5, 1971, Mr. Meacham and Mr. Mitchell agreed to and signed a Stipulation of Facts which was filed in the appeal and agreed that the appeal be submitted to the Court for decision with the understanding that counsel would file briefs with the Court.

Mr. Meacham, Mr. Mitchell and Mr. Gray have furnished the Court their briefs which presented their position, argument and authorities and the briefs have been placed in the file.

The Court after reading and re-reading these briefs would finally conclude that the scales tip towards the position and argument of the Foss Reservoir Master Conservancy District in that the Robbins letter dated February 9, 1951 ("Exhibit 5"), the Attorney General's Opinion dated October 8, 1962 ("Exhibit 10"), the expenditure of approximately \$27,000,000 by the United States for the reservoir and aqueduct system ("Stipulation of Facts -9-") would leave a situation where the Oklahoma Water Resources Board would not be in a position to work out what it considered to be an equitable allocation of vested surface water rights in 1969 which would deny to the District the needed acre feet of vested rights which had been contemplated during the planning and construction of the project.

IT IS THE DECISION, ORDER AND JUDGMENT OF THE COURT:

That Final Order No. 33 of the Oklahoma Water Resources Board pertaining to Stream System 1-8, Washita River Stream System, dated August 12, 1969, is MODIFIED so as to establish the priority for the vested rights in surface waters in the United States of America and the Foss Reservoir Master Conservancy District in the amount of 66,900 acre feet as of February 9, 1951, otherwise Final Order No. 33 is affirmed.

JOURNAL ENTRY OF JUDGMENT

ON ADMINISTRATIVE APPEAL

On this the 18<sup>th</sup> day of August, 1972, the Court being  
fully advised, finds:

This cause arose as an appeal from action taken by the  
Oklahoma Water Resources Board when it entered its final Order No. 33  
on August 12, 1969, determining vested surface water rights in the  
Washita River Stream System. Final Order No. 33 set the appropriative  
priority of the Fort Cobb Reservoir Master Conservancy District to  
14,834 acre-feet of water per calendar year with a priority date of  
February 9, 1951, and 14,566 acre-feet of water per calendar year  
with a priority date of August 23, 1968. The Fort Cobb Reservoir  
Master Conservancy District contends on appeal that the appropriative  
priority date should have been February 9, 1951, as to the total of  
29,400 acre-feet of surface water allocated to the district per  
calendar year. All relevant records and documents have, by stipulation  
of the parties, been made a part of the record on appeal.



Extensive briefs have been filed by the parties and made a part of the file and record herein.

Upon consideration of the entire record and briefs of the parties, the Court concludes the decision of the agency, the Oklahoma Water Resources Board, in promulgating its Final Order No. 33, was clearly erroneous in view of the reliable, probative, substantial and competent evidence considered, and that errors of law were committed by such agency when it applied statutory provisions to establish the priorities in this cause in its Final Order No. 33, which were enacted subsequent to February 9, 1951. The Court further concludes that Final Order No. 33 should be modified to set an appropriate priority date of February 9, 1951, for the entire 29,400 acre-feet of surface water per calendar year allocated to the Fort Cobb Reservoir Master Conservancy District and the United States of America, and that all other findings of facts and conclusions of law in Final Order No. 33 be affirmed.

It is therefore ORDERED, ADJUDGED AND DECREED by the Court that Final Order No. 33 of the Oklahoma Water Resources Board, pertaining to Stream System 1-8, Washita River Stream System, dated August 12, 1969 be, and the same is hereby modified so as to set an appropriate priority date of February 9, 1951, for vested rights to 29,400 acre-feet of surface water per calendar year in the Fort Cobb Reservoir Master Conservancy District and the United States of America, and that all other agency findings of fact and conclusions of law in Final Order No. 33 be affirmed.


