Rationale/Policy/Regulation

Any interference with District Operations including interference or disruptive behavior occurring at Board Meetings and Membership Meetings causes the District to incur needless additional expense including legal expense. The Board reserves the right to revoke and terminate a member's benefit unit and water connection, and terminate water service, if the Board by majority vote, determines that a member is engaging in disruptive behavior that interferes with the operations of the District including meetings of the Board and the Membership.

RULES AND REGULATIONS

ANY INTERFERENCCE WITH DISTRICT OPERATIONS INCLUDING INTERFERENCE OR DISRUPTIVE BEHAVIOR OCCURING AT BOARD MEETINGS AND MEMBERSHIP MEETINGS AND CAUSES THE DISTRICT TO INCURE NEEDLESS ADDITIONAL EXPENSES INCLUDING LEGAL EXPENSE THE BOARD RESERVES THE RIGHT TO REVOKE ABD TERMINATE A MEMBER'S BENEFITT UNIT AND WATER CONNECTION, AND TERMINATE WATER SERVICE INDEFINATELY. IF THE BOARD BY MAJORITY VOTE, DETERMINES THAT A MEMBER IS ENGAGING IN DISRUPTIVE BEHAVIOR AND HARRASSMENT THAT INTERFERES WITH THE OPERATIONS OF THE DISTRICT INCLUDING MEETINGS OF THE BOARD, BOARD MEMBER RETENTION, AND MEMBERSHIP THE MEMBER WILL BE TERMINATED FROM OUR ORGANIZATION. IF SAID MEMBR WISHES TO APPEAL THE ACTION OF THE BOARD THE MEMBER MAY PLEAD THEIR CASE AND HOLD A VOTE AT THE NEXT REGULAR BOARD MEETING AFTER TERMINATION. THE MEMBER VOTE WILL BE UPHELP BY THE BOARD. IF NOT ADDRESSED AT THE FOLLOWING MONTH OF DISCONNECTION CASE IS CLOSED AND NO OTHER ACTION WILL BE TAKEN.
